## 1. OBJECTIVES

### 1) The following objectives of this paper are:

- To show the advantage of mackerel *refugia* to local people, fishermen and community fisheries
- To increase the knowledge and understanding of fisheries resource, especially mackerel to people and fishers

## 2. ACTIVITIES

### 2) Department of Fisheries Conservation and Koh Kong Fisheries Administration Cantonment organized the meeting of the extension on the importance of mackerel fisheries *refugia* to people, fisheries and community fisheries having the period of 3 days starting on 14 to 16 March 2019 as follow:

- 1<sup>st</sup> day meeting started on 14 March at Village 1 and Village 2, Koh Kapi commune, Koh Kong district, Koh Kong province, which is 50 participants (see annex 1).
- 2<sup>nd</sup> day meeting started on 15 March 2019 at Koh Srolao village, Koh Kapi commune, Koh Kong district, Koh Kong province, which is 53 participants (see annex 2).
- 3<sup>rd</sup> day meeting started on 16 March 2019 at Village 1, Village 2, and Korng Kang village, Peam Krasob commune, Mondol Sema district, Koh Kong province, which is 59 participants. (see annex 3).

## 3. RESULTS

### 3) The creation of mackerel fisheries *refugia* site is really important in term of increasing fish stock and catching, and even contributing to enhancement of local livelihood depending on fishing. People, fishers, and community fisheries are happy to join the meeting, providing more knowledge and more understanding about the importance of mackerel fisheries *refugia*. Therefore, they wish to join the protection and conservation of fisheries resource, especially mackerel during the fishing closed season on 15 January to 31<sup>st</sup> March.
