1. OBJECTIVES

- 1) The following objectives of this paper are:
 - To mainstream the proclamation of MFMA in kep to local communities, fishermen, and other stakeholders
 - To show the importance and advantage of MFMA in kep to local communities, fishermen, and other stakeholders
 - To promote the dissemination of MFMA in Kep the whole province
- 2) The meeting of dissemination of MFMA in kep started the implementation on 18 to 20 March 2019 at following target areas.
 - a) On 18 March 2019 at Thmey village, Sangkhat Prey Thom, Kep city, Kep province;
 - b) On 19 March 2019 at Am Peng village, Ang Kol commune, Damnak Chhorng Or district, Kep province; and
 - c) On 20 March 2019 at Kep village, Sangkhat Kep, Kep city, Kep province

2. PROCESS OF FACILITATION AND SUPPORT

- 3) The meeting of dissemination on the MFMA in Kep have been organized and facilitated by Kep FiAC of Kep DoA, supporting technical aspects from DFC/FiA and budget from SEAFDEC/UNEP/GEF /Fisheries *Refugia* Project.

3. ACTION PROCESS AND RESULTS

- 4) The meeting of the dissemination had processed following action program
 - Welcomed by local and district authority representatives
 - Speech remarked and opening the meeting by Director of Kep FiAC
 - Presentation of marine fisheries management area made by technical officer from Kep FiAC
 - Presentation of the proclamation of marine fisheries management area in Koh Po and Koh Tonsay in Kep made by technical officer from Kep FiAC
 - Presentation of role and utilities of marine fisheries management area made by technical officer from Kep FiAC
 - Closes a meeting by local authority representatives
- 5) The meeting had conducted in three target areas around coastal zones such as Sangkhat Prey Thom, sangkhat Kep of Kep city, Ang Kol commune of Damnak Chhorng Or district, participating local communities, fishermen, member of CFi, local and district authorities, police post, water boundary police. The meeting was 147 participants including 55 females:
 - 27 females of 48 participants from Thmey village, Sangkhat Prey Thom, Kep city, Kep province (Annex 1);
 - 23 females of 56 participants from Am Peng village, Ang Kol commune, Damnak Chhorng Or district, Kep province (Annex 2); and
 - 5 females of 38 participants from Kep village, Sangkhat Kep, Kep city, Kep province (Annex 3)

4. CONCLUSION

- 6) It was concluded that participants understood clearly about the importance of MFMA, especially the size and boundary of MFMA, and each zoning in MFMA, that is a basic for the proper management and use base on the proclamation of the creation of MFMA

5. SUGGESTION

- 7) Based on the meeting of the dissemination, participants suggested placing buoys or notes at the boundary of protection area and banned area such as conservation area, diving area, ecotourism area, research study area, and fisheries *refugia* area.
