1. CHAIRPERSON KEYNOTE

- 1.1 Refugia was introduced as one of the fisheries management tool in order to tackle the regional and global resource depletion issues.
- 1.2 The Establishment and Operation of a Regional System of Fisheries Refugia in the South China Sea and Gulf of Thailand is an initiative of the United Nations Environment Program (UNEP) and the Global Environment Facility (GEF) through the Southeast Asian Fisheries Development Center (SEAFDEC). This project is to manage and preserve the important marine species and habitats in the Southeast Asian region and was participated by six (6) regional countries namely Cambodia, Indonesia, Malaysia, Philippines, Thailand and Vietnam.
- 1.3 In Malaysia, two (2) areas have been proposed as refugia sites:
 - 1.3.1 Tanjung Leman, Johor (*Panulirus polyphagus* mud spiny lobster) and Kuala Baram, Sarawak (*Penaeus monodon* tiger prawn).
 - 1.3.2 This project will be carried out for four (4) years from 2017 until 2020 and funded by SEAFDEC/UNEP/GEF. Whereas, Malaysia will be co-financing through the Operation and Development Allocations of the Department of Fisheries Malaysia under the Eleventh Malaysian Plan.
 - 1.3.3 A total allocation of USD3.0 million was approved by UNEP / GEF in January 2016 to be distributed to countries participating in the project.
 - 1.3.4 Malaysia is expected to receive an allocation of USD250, 000.00 (RM1.0 million) over a four-year period.
- 1.4 Following the MOU between Malaysia and SEAFDEC which was signed on June 20, 2017:
 - 1.4.1 Malaysia shall provide Quarterly Work Plan in order to request Cash Advance from SEAFDEC / UNEP / GEF.
 - 1.4.2 Quartely Work Plans shall require endorsement from the National Fisheries Refugia Project Committee.
- 1.5 This meeting was held to inform the implementation status of the Fisheries Refugia Project at the national level and to approve the quarterly work plan which will be submitted to SEAFDEC / UNEP / GEF.

2. DISCUSSION

- 2.1 Presentation of Fishing Refugia Project Implementation Status
 - 2.1.1 The committee took note the status of the implementation of the project.
- 2.2 Presentation of Costed Quarterly Work Plan
 - 2.2.1 The committee acknowledged and approved the plan in order to apply cash advance request amount of USD27, 230.00.
 - 2.2.2 This document will be amended according to the given format and submitted to SEAFDEC / UNEP / GEF as soon as possible.

3. OTHER MATTERS

- 3.1 Update of the Refugia Information Center (RIC)
 - 3.1.1 Johor State Fisheries Office is in the process of applying an exemption on the rent payment with the premise owner.
 - 3.1.2 This center will be officiated by the Director General of Fisheries Malaysia on November 20, 2017.
 - 3.1.3 Posters and lobster replicate are being prepared for the opening ceremony.

4. CLOSING

- 4.1 The Chairman requested a comprehensive plan shall be made for the implementation of this project by taking into account of various aspects including scientific, social and financial.
- 4.2 Besides that, the Chairman expressed his gratitude for the commitment made by the committee in the refugia project.
