Objectives

Public awareness program about the fisheries refugia program and to gather feedback from the stakeholders.

Methodology, Activities and Materials

The Refugia Project Consultation Briefing was given by Research Officer Mr. Ryon Siow from the Fisheries Research Institute (FRI), Kampung Acheh, Sitiawan, Perak. The briefing was divided into two (2) sessions, whereby the first session was for the local agencies involved while the second session was for the fishermen.

Participants

A total of 41 people attended the briefing on 10 October 2017 at the Conference Room, Seri Malaysia Hotel, Kuala Rompin, Pahang. They were made up of fishermen, tourist guides, other private sector workers and government officials, including the staff of the Department of Fisheries.

Issues & results

The importance of Fisheries Refugia were presented to the participants. The lobster resource is being threatened with reduction by fisheries activities such as bottom trawling. It is generally acknowledged that such trawling activities is harmful to the sea bed including coral areas. Based on studies by Dr. Alias (2000), lobsters were found to spawn between July and September, annually, with the peak spawning occuring in August.
