### HIGHLIGHT ACTIVITIES

- 1) On the First day, a courtesy call to Ms. Olive Gregorio, Municipal Environment & Natural Resources Officer was made. A meeting was conducted together with the Refugia Management Team. We informed her we will be conducting a quarterly monitoring of activities undertaken by the enumerators in the fish landing areas in Masinloc, Zambales, Ms. Gregorio informed us that regularly, the two staff report to their office and update them about the activities conducted in the landing sites.
- 2) On the second day, we meet the two Enumerators Assigned in Masinloc, an overview was discussed by Mr. Ayanan on the on NSAP Sampling Protocol, and we also reviewed the filled data forms to check the quality of data they were collecting.
- 3) We also visit the actual fish landing sites in Matalvis Fish Port & Baloganon Landing Site. Enumerators were also observed in their species identification of fish in the landing sites to check if accurate identification was done. Blank data forms were also provided to the enumerators to be used in their sampling in the area.
