HIGHLIGHT ACTIVITIES

- 1)** On the First day, a courtesy call to Ms. Olive Gregorio, Municipal Environment & Natural Resources Officer was made. A short meeting was conducted together with the Refugia Management Team. We informed her the purpose of the trip and the schedule of the upcoming fisheries refugia stakeholders consultation workshop. During the meeting the group requested Ms. Gregorio if she can provide contact numbers for the target participants of the workshop.
- 2)** After the meeting, we visited the Bakasyunan resort and hotel. We conducted ocular inspection on the meeting rooms and accommodation for the upcoming stakeholder's workshop, a Request for Quotation (RFQ) form was given to the sales manager of the said resort to quote the price for their meeting package.
