1. Open meeting

- 1) The consultation meeting on the reviewing 5 year-action plan (2019-2023) for marine fisheries management area and blue swimming crab fisheries refugia in Koh Po and Koh Tonsay Archipelago, Kep was organized by Fisheries Administration (FiA) of Cambodia on 1st August 2019, funded by SEAFDEC/UNEP/GEF Fisheries *Refugia*. The meeting was conducted at Fisheries Administration under presided by H.E Srun Limsong, Deputy Director General of Fisheries Administration, which was attended by 19 participants in total from legal team of Fisheries Administration, Director of Department of Agriculture, forestry and Fisheries in Kep and Vice Chief of Kep Fisheries Administration Cantonment (see Annex 1, 2 &3).
- 2) H.E Srun Limsong, Deputy Director General of Fisheries Administration welcomed all participants, taking their opportunity to join that meeting today to discuss reviewing 5 year-action plan for marine fisheries management area and blue swimming crab fisheries refugia in Koh Po and Koh Tonsay Archipelago, Kep. He added that 5 year-action plans (2019-2023) is developed based on the MAFF's proclamation on the establishment of management area of marine fisheries management area in Koh Po and Koh Tonsay Archipelago, Kep stating in 5 Article. The development of the management plan is very important in sustainable marine fisheries resource use and management in Kep. Therefore, he proposed the meeting to pay an attention and active discussion to take its implementation effectively.

2. Presentation on 5 years (2019-2023) action plan for marine fisheries management area and blue swimming crab fisheries refugia in Kep

- 3) Mr. Ouk Vibol presented the draft of 5 years action plan for marine fisheries management area and blue swimming crab fisheries refugia in Koh Po and Koh Tinsay Archipelago, Kep. Before starting to present, he expressed thanks very much for H.E Srun Limsong, chair meeting and all participants coming to attend the meeting today.
- 4) He noted that the establishment of the 5 years action plan is referred to the Article 5 of the proclamation. Regarding that case, FiA collaborating with Department of Provincial Agriculture, Forestry, and Fisheries and FiAC in Kep develops the action plan funded by IUCN, MCC and SEAFDEC/UNEP/GEF Fisheries Refugia Project. The contents of action plan consist of Introduction, Marine Fisheries Management Area in Koh Po and Koh Tonsay Archipelago, Kep, Involved Legislation Instruments, Action Plan, Structure of Action Implementation and Responsibility, Estimated Budget, Monitoring and Evaluation, Reference, and Appendix.

3. Discussion on 5 years (2019-2023) action plan for marine fisheries management area and blue swimming crab fisheries refugia in Kep

- 5) H.E Chair meeting proposed the meeting to discuss those points proposed by Mr. Ouk Vibol.
- 6) Mr. Ing Try proposed consideration and the addition of the policy and strategy plan for fisheries sector management in Kep into introduction.
- 7) Mr. Theng Borin replied that provincial policy of Kep is related to tourism sector as well as marine fisheries resource protection and conservation, especially blue swimming crab to ensure its stock. Regarding that issue, provincial authority has participated to make dissemination about blue swimming crab fishing close to fishermen as well as tourists.
- 8) Mr. Chin Da proposed to add an extension activity in Objective 1 that one activity is very important in law enforcement.
- 9) Mr. Thay Somany proposed the meeting to consider water pollution from bordering countries and he proposed to develop aquaculture in any space of MFMA.
- 10) Mr. Hav Viseth proposed to do seaweed and green mussel culture helping to improve water quality.

- 11) Mr. Mr. Suy Sereywath proposed a consistent writing from each paragraph and to integrate Marine Fisheries Research and Development Institute (MAFReDI) into the implementation of those activities.
- 12) Mr. Ouk Vibol agreed to take all proposals from the meeting and corrected the action plan based on the meeting comments.

4. Close meeting

13) H.E Srun Limsong recommended that the meeting agreed and supported 5 year action plan for marine fisheries management area in Koh Po and Koh Tonsay Archipelago, Kep contributing to sustainable marine fisheries resource management in Kep and proposed Mr. Ouk Vibol to correct the action plan based on the meeting comments. The meeting closed at 5:30pm
