## 1. Meeting Objectives

- To disseminate the Ministry of Agriculture, Forestry, and Fisheries' proclamation on the creation of management area of mackerel *refugia* to local people, fishermen and community fisheries to understand about that proclamation
- To increase the knowledge and understanding of fisheries resource, especially mackerel to people and fishers in order to reduce illegal fishing

## 2. Meeting Methodology

Technical working team from Department of Fisheries Conservation and Koh Kong Fisheries Administration Cantonment delivered posters and documents related to the proclamation of creation of management area of mackerel refugia in Koh Kong to all participants. Moreover, officer from Department of Fisheries Conservation also presented the proclamation meaning and the importance of mackerel refugia to participants to understand about those issues. After that organizers provided chances to participants to ask and suggest all issues raised during the meeting.

## 3. Meeting Activities:

Department of Fisheries Conservation collaborating with Koh Kong Fisheries Administration Cantonment organized the meeting on the extension of the MAFF's proclamation on the creation of management area of mackerel *refugia* to people, fisheries and community fisheries with the period of 3 days starting on 30 January to 01 February 2020 as follows:

- 1<sup>st</sup> day meeting started on 30 January 2020 at Village 1 and Village 2, Koh Kapi Commune, Koh Kong District, Koh Kong province, was attended by 59 participants (16 females) from Village 1 and Village 2, Koh Kapi commune, Koh Kong District, Koh Kong province (see annex 4).
- 2<sup>nd</sup> day meeting started on 31 January 2020 at Village 4, Sangkhat Dornng Tung, Kem Reak Phumin City, Koh Kong province, was attended by 59 participants (29 females) from Village 4, Sangkhat Dornng Tung, Kem Reak Phumin city, Koh Kong province (see annex 5).
- 3<sup>rd</sup> day meeting started on 01 February 2020 at Village 1, Village 3 and Boeung Kachang village, Bak Khlorng Commune, Mondol Sema District, Koh Kong province ((see annex 6), was attended by 54 participants (36 females) from Village 1, Village 3, and Boeung Krachang Village, Bak Khlorng commune, Mondol Sema district, Koh Kong province.

## 4. Meeting Results:

The extension meeting on the MAFF's proclamation of creation of management area of mackerel *refugia* in Koh Kong province was attended by Department of Fisheries Conservation, Koh Kong Fisheries Administration, Local Authorities, Community Fisheries, and Fishermen with total 172 participants of 81 females. That meeting is really important in terms of increasing fish stock and catching, and even contributing to enhancement of local livelihood depending on fishing. According to pretest, 96% of participants did not know about the meaning of MAFF's proclamation on creation of management area of mackerel refugia at Peam Krasob, Koh Kong province. After meeting, 95% of participants understood the MAFF's proclamation meaning. Therefore, fishermen and community fisheries are happy to join the meeting, providing more knowledge and more understanding about the importance of mackerel fisheries *refugia* and the MAFF's proclamation. Finally, Technical Working Team from DFC, Koh Kong Fisheries Administration Cantonment, and Local Authorities suggested all participants to get that knowledge from the

meeting to be transferred to other fishermen not to join the meeting. They promised to do continuous extension to villagers and friends not to come to join the meeting.
