1. OPEN A MEETING

- 1.1.** The 2nd Meeting of Technical Working Group for Marine Fisheries Protection and Conservation Area in Koh Kong province was organized by Fisheries Administration (FiA) of Cambodia collaborating with Koh Kong Provincial Hall Administration on 07 August 2020, funded by SEAFDEC/UNEP/GEF Fisheries *Refugia*. The meeting was conducted at Koh Kong Provincial Hall Administration under presided by Mr. Sok Sothy, Deputy Governor of Koh Kong and as Chairperson of TWG, which was attended by 25 participants in total from Fisheries Administration, Department of Agriculture, Forestry, and Fisheries, Fisheries Administration Cantonment in Koh Kong province, Department of Environment, Department of Tourism, Department of Land Management, Urban Planning and Construction, Koh Kong Provincial Hall Administration, Kiri Sarkor District Administration, Mondol Sema District Administration, Sre Ambil District Administration, Koh Sdach Commune, Koh Kong Provincial Police, Koh Kong Provincial Military Police, Maritime Police, and NGOs (see Annex 1, 2,3&4).
- 1.2. Mr. Sok Sothy** welcomed to all participants taking their opportunities to attend the meeting today and informed meeting that this is the 2nd meeting of Technical Working Group for Marine Fisheries Protection and Conservation Areas in Koh Kong province, focusing on 4 agendas including 1) Preparation for 5 years Action Plan for Management of Mackerel Refugia in Koh Kong Province; 2) Action Plan for Closing Mackerel Fishing starting on December 2020 to March 2021; 3) Current Management of Estuarine Terrapin (*Batagur affinis*) and Siamese crocodile (*Crocodylus siamensis*) in Sre Ambil Channel System, Koh Kong province; and 4) Current Process of Establishment of Marine Fisheries Management area (MFMA) in Koh Sdach Archipelago, Koh Kong. After that he declared to open a meeting from now.

2. PRESENTATION OF PROGRESS REPORT DONE BY TECHNICAL WORKING GROUP AND DISCUSSION

2.1. Draft Action Plan for Mackerel Refugia Management Presented by Mr. Ouk Vibol

- 2.1.1.** Firstly, **Mr. Ouk Vibol** expressed thanks very much to **Mr. Sok Sothy** and all members of Technical Working Group that are presented today. Then, he informed meeting that mackerel refugia has been recognized officially by Koh Kong Governor and Minister of Agriculture, Forestry, and Fisheries. Therefore, to ensure effective mackerel management and uses, it is needed to have an action plan for mackerel management. In that case, he also prepared 5 years action plan for management of mackerel refugia in Koh Kong province and proposed the meeting for consideration and provision of their inputs into the plan. Thus he proposed the meeting to discuss Koh Kong Provincial Hall Administration's and FiA's Logos, Title, Contents, Goal, and Objectives (See Annex 2).
- 2.1.2. Mr. Chairperson of the meeting** proposed the meeting to consider and discuss Mr. Ouk Vibol draft action plan of mackerel refugia in Koh Kong, focusing on Koh Kong Provincial Hall Administration's and FiA's Logos, Title, Contents, Goal, and Objectives.
- 2.1.3. Mr. Prak Vichet**, Governor of Mondol Sema District, agreed commonly the action plan for management of mackerel refugia.
- 2.1.4. Veth Sonym**, Deputy Director of Provincial Department of Environment, proposed the meeting to consider the Title and to delete (action word).
- 2.1.5. Mr. Ouk Vibol** explained that the plan is to want to show about the Point of Action, so he agreed the Title based on the meeting spirit.

- 2.1.6. Mr. Kao Monirith**, Deputy Director of Marine Fisheries Administration Inspectorate, was interested in Goal and proposed the meeting to add the “word of other fish species” because when mackerel refugia well managed, other fish species appeared.
- 2.1.7. Mr. Prom Rithy**, Vice Head of Maritime Police agreed the Title based on Veth Sonym’s proposal
- 2.1.8. Mr. Chairperson of the meeting** expressed that “action word” is to want to show it into the plan, so he proposed to provide ability for Department of Fisheries Conservation and the meeting to make decision. Generally, he accepted the meeting spirit such as Logos of the Koh Kong Provincial Administration and Fisheries Administration, Title, Preface, Abbreviation, and proposed to revise the meaning of introduction such as cutting the section of mackerel biology, the status of mackerel fishing, and threats and moved into new section.
- 2.1.9. Mr. Ee Meng Leang**, Director of Department of Agriculture, Forestry, and Fisheries agreed the original meeting of the action plan, but he proposed to delete “the word of conservation” and replace the “the word of management” because that word is sensitive with fishermen.
- 2.1.10. Mr. Chairperson of the meeting** summarized meeting as following:
- Accepted Logos of the Koh Kong Provincial Administration and Fisheries Administration,
 - Agreed keeping its title as the original meaning,
 - Supported to revise introduction section
 - Supported Koh Kong Fisheries Administration Cantonment working with Department of Fisheries Administration/FiA on the log frame of action plan for mackerel refugia management in Koh Kong province.

2.2. PLAN FOR CLOSED FISHING OF MACKEREL PRESENTED BY FIAC IN KOH KONG

- 2.2.1. Mr. Seng Bunnna**, Deputy Chief of Koh Kong Fisheries Administration Cantonment, presented the plan for closed fishing of mackerel at Peam Krasob, Koh Kong province starting from December 2020 to March 2021. His presentation was focusing on 6 points including 1) establishing and strengthening patrolling group, 2) installing mooring buoys at the boundary of mackerel refugia, 3) disseminating noticed letter on closed fishing of mackerel issued by Koh Kong Provincial Administration, 4) Cracking down illegal fishing, and 5) collaborating (See Annex 2).
- 2.2.2. Mr. Ouk Vibol** proposed the meeting to consider and provide ability for DFC/FiA to work the discussion with FiAC in Koh Kong province about the budget proposal for closed fishing of mackerel starting from December 2020 to March 2021, and proposed Koh Kong Governor to help issue noticed letter of closed fishing of mackerel upcoming.
- 2.2.3. Mr. Chairperson of the meeting** agreed Mr. Ouk Vibol proposal and requested DFC/FiA to assist the preparation of draft letter. He informed FiAC that if there is meeting difficulty in cracking down illegal fishing, please report to Provincial Administration to address that issue.

2.3. CURRENT MANAGEMENT OF ESTUARINE TERRAPIN (*Batagur affinis*) AND SIAMESE CROCODILE (*Crocodylus siamensis*) IN SRE AMBIL CHANNEL SYSTEM, KOH KONG PROVINCE PRESENTED BY WCS

- 2.3.1. Mr. In Hul**, Deputy Director of Department of Fisheries Conservation, presented Current Management of Estuarine Terrapin (*Batagur affinis*) and Siamese crocodile (*Crocodylus siamensis*) in Sre Ambil Channel System, Koh Kong province. His presentation was two

sections; first section was talking about Management of Estuarine Terrapin (*Batagur affinis*) and second section was focusing on the management of Siamese crocodile (*Crocodylus siamensis*). He informed the meeting that Estuarine Terrapin is endangered species classified by Red List of IUCN. In that case, WCS provided budgets to work protection and conservation of that turtle in Sre Ambil Channel System which is main habitat only for its living and spawning. To ensure sustainable management of turtle species, WCS prepared action plan for its management including turtle nest protection, releasing program, monitoring, and saving and collaboration. Then he also presented about the management of local crocodile specie and it is also endangered species classified by Red List of IUCN. He added that WCS granted funds for the crocodile specie management such as dissemination and education, establishment of community fisheries, law enforcement strengthening, and crocodile nest and habitat protection, and research activities (See Annex 2).

2.3.2. Mr. Ouk Vibol expressed that Estuarine Terrapin (*Batagur affinis*) and Siamese crocodile (*Crocodylus siamensis*) is under managed by Fisheries Administration, Provincial Administration, and Provincial Department of Agriculture, Forestry, and Fisheries. Estuarine Terrapin is specie presenting in Ambil Channel System only and is in different status with other species migrating to other place for living and spawning. Thus if that place was destroyed, it caused impacts to turtle and can reach to extinction of that specie.

2.4. PROCESS OF ESTABLISHMENT OF MARINE FISHERIES MANAGEMENT AREA IN KOH SDACH ARCHIPELAGO, KOH KONG PROVINCE PRESENTED BY FFI

2.4.1. Mr. Chea Phalling, Project Coordinator of MPA of FFI-Cambodia presented process of establishment of Marine Fisheries Management Area in Koh Sdach Archipelago, Koh Kong province. At first, he would like to show the meeting to know about the history of MPA program creation. The program has started to implement activities since 2018 until now including main activities such as Management of MFMA in Koh Rong, Preah Sihanouk province, protection and conservation of marine animal species (i.e. marine turtles, seas horse, and other biodiversity species), illegal wildlife animal trade, and research activities. Then, he showed the process of establishment of MFMA in Koh Sdach. So far, the project finished research studies and mapping completely and will have a plan to conduct stakeholder consultation meeting of zoning division for management and boundary demarcation with participation from FiA, FiAC, local authorities, private sector as well as community fisheries. In particular, the project has worked closely with FiAC in Koh Kong and community fisheries through strengthening patrolling, dissemination and education, and capacity building of CFis member and FiAC's officers (See Annex 2).

2.4.2. Mr. Khim Chandy, Kiri Sarkor District Governor proposed participation from private sector and community fisheries for stakeholder consultation meeting, which are a main actors in defining boundary and zoning for management, and he proposed FFI to continue supporting both technical and budgets for CFi to accelerate the activities of marine fisheries protection.

2.4.3. Mr. Ouk Vibol agreed District Governor proposal and informed the meeting that zoning is needed to participate from all sector as well as private sector in order to do whatever the process of zoning defining to get successful.

2.4.4. Mr. Chairperson of the meeting agreed Mr. Ouk Vibol proposal.

2.4.5. Mr. Kao Monirith, Deputy Director of Marine Fisheries Administration Inspectorate asked FFI that Did FFI has a project to do a research study of gasoline legacy discharging from vessels beside plastic bags.

2.4.6. Mr. Chea Phallin responded that research project on plastic bag residues has just started to study and it is the kind of not dissolvable residues. For gasoline legacy, there is not project to do a research study on it yet until now and FFI encouraged CFi to do that job by themselves.

3. SUMMARY OF THE MEETING RESULTS

3.1. After discussion, **Mr. Chairperson of the meeting** summarized the results of the meeting as following:

- Supported draft 5 year-action plan for mackerel refugia management at Peam Krasob, Koh Kong,
- Agreed FiA to continue working with FiAC on preparation of the log frame of action plan for mackerel refugia management,
- Supported FFI to accelerate stakeholder consultation meeting on zoning for MFMA in Koh Sdach Archipelago, Koh Kong province,
- Supported WCS to continue the management of Estuarine Terrapin (*Batagur affinis*) and Siamese crocodile (*Crocodylus siamensis*) in Sre Ambil Channel System.
- Continue 3rd Technical Working Group meeting for 4th semester of year 2020.

4. CLOSURE OF THE MEETING

4.1. Mr. Sok Sothy thanked all participants very much, taking their opportunities to join that meeting today and get fruitful results. He declared to close the meeting at 4:30pm.
