## REPORT

#### AGENDA 1 OPENING OF THE WORKSHOP

The Workshop on Fisheries Refugia Boundary Marking at Surat Thani Site was organized by Surat Thani Fisheries Provincial Office on 31<sup>th</sup> May 2022, back to back with the workshop on Fisheries *Refugia* Operational Management at Surat Thani Site on 30<sup>th</sup> May 2022. The workshop was conducted at fisheries *refugia* site around Koh Sed in Chaiya District of Surat Thani Province, aimed at being the initial activity for operational management at Surat Thani fisheries refugia site and for strengthening cooperation of fishers, civil society, and community organizations in the management of fisheries refugia at site. Besides boundary marking, seed releasing of significant aquatic animals was done in fisheries refugia for the purpose of fisheries resources enhancement and for celebrating the success of fisheries refugia establishment in the area as well. The workshop were participated by members of Operational Management Board for Fisheries Refugia in Surat Thani Site, small-scale fishers, officers of Department of Fisheries, and fisheries refugia project officers. The activities were aerial recorded using drone by officers of Southeast Asian Fisheries Development Center (SEAFDEC), and aerial photographed by the members of Paramotor Club Surat Thani. In total, there were 56 participants cooperated in the workshop. Agenda and list of participants are shown in Annex 1 and Annex 2, respectively.

#### 1.1 OPENING ADDRESS BY DIRECTOR OF SURAT THANI FISHERIES PROVINCIAL OFFICE

By the fishing pier at the mouth of Phum Riang Canal in Phum Riang Subdistrict, Mr. Itthiphon Kwathai, Director of Surat Thani Fisheries Provincial Office, expressed his appreciation to all participants for their participation in the workshop on fisheries refugia boundary marking around Koh Sed of Surat Thani Site, another one day back to back with the previous day of the workshop on operational management. He noted that this was the further step for ecosystem-based management at fisheries refugia site by cooperation of the communities. He thanked small-scale fishers in Phum Riang Subdistrict and officers of Surat Thani Fisheries Provincial Office for their collaboration in preparing the buoyage for boundary marking. He mentioned that beside the marking activity, there would be seed releasing of significant aquatic animals in the area which were penaeid shrimps and blue swimming crabs. In this regard, he conveyed his thanks to Viya Crab Products Co., Ltd. for support of blue swimming crabs and to Surat Thani Coastal Aquaculture Research and Development Center for support of penaeid shrimps for seed releasing. He thanked SEAFDEC for support of drone aerial recording and members of Paramotor Club Surat Thani for their joyful participation. Finally, he expressed his hope that the workshop would complete with high achievement leading to proper management of fisheries *refugia* at Surat Thani Site from now on.

#### AGENDA 2 INTRODUCTION OF BUOYAGE PREPARATION

**Mr. Somporn Kuasakul**, Head of Fisheries Administration and Management Group of Surat Thani Fisheries Provincial Office and concurrently a member of the Operational Management Board, informed the participants that preparation of the buoyage was already done at the place of Local Fishing Community Organization of the Group for Releasing Blue Swimming Crab into Ban Don Bay of Thai Seas, Ban Leam Pho, Phum Riang Subdistrict, Chaiya District, Surat Thani Province. He introduced to the participants the composition of buoyage for fisheries *refugia* boundary marking, numbers of buoys for

placing, interval for each buoy, depth of sinkers, how to place the buoys, and the layout of boundary marking at site.

The buoy is made of 30-liter polypropylene bucket, filled with polyurethane foam. Logo and the name "Department of Fisheries" was water-proofed spray painted at one side of the buoy while "Conservation Area" was painted at the opposite side. Reflective stripe was placed at its upper side. The total of 40 buoys was prepared for boundary marking. Ready-prepared buoys are shown in Figure 1.

A concrete pipe, 80 centimeters in diameter and 40 centimeters in depth, was used as a sinker for each buoy. A buoy and a sinker were connected together by a 12-meters polypropylene rope, 18 millimeters in diameter. Concrete sinkers and connecting ropes can be seen in Figure 2.

#### AGENDA 3 SEED RELEASING AT SURAT THANI FISHERIES REFUGIA SITE

In addition to boundary marking, an activity of seed releasing for fisheries resources enhancement was carried out at Surat Thani fisheries *refugia* site. The total of 1,000,000 blue swimming crab megalops was provided by Viya Crab Products Co., Ltd., and 300,000 penaeid shrimp post larvae were provided by Surat Thani Coastal Aquaculture Research and Development Center. In this regard, participants were requested to load the packages of those baby crabs and shrimps in oxygenated water onto 2 boats heading to Koh Sed, the fisheries *refugia* of Surat Thani Site. On arriving at fisheries *refugia* area, all the seeds were released with delight. The activities are shown in Figure 3.

## AGENDA 4 FISHERIES REFUGIA BOUNDARY MARKING AT SURAT THANI SITE




Figure 4 Fisheries refugia boundary and its buoy-marking points at Surat Thani Site

**Mr. Somporn Kuasakul**, Head of Fisheries Administration and Management Group of Surat Thani Fisheries Provincial Office and concurrently a member of the Operational Management Board, is responsible for leading fisheries *refugia* marking activity. **Mr. Somporn**, in collaboration with members of Operational Management Board and small-scale fishers in the area, loaded all 40 sets of buoys onto 3 fishing boats moored at the mouth of Phum Riang Canal in Phum Riang Subdistrict. The buoys-loaded boats then headed to Surat Thani fisheries *refugia* site at Koh Sed where the buoys, together with their sinkers, were placed for marking. At the site, GPS devices were used to locate 40 geographic coordinates, with an interval of 375 meters, for placing the buoys lining as the boundary of fisheries *refugia* at Surat Thani Site. Geographic coordinates for fisheries *refugia* boundary line are shown in Table 1 which were indicated in the satellite maps illustrated in Figure 4.




Figure 5 (cont.) Activities for fisheries refugia boundary marking at Surat Thani Site




Figure 5 (cont.) Activities for fisheries *refugia* boundary marking at Surat Thani Site

#### AGENDA 5 PRESS INTERVIEW FOR ESTABLISHMENT AND OPERATION OF FISHERIES REFUGIA AT SURAT THANI SITE

Following the activities for boundary marking, **Ms. Praulai Nootmorn**, Senior Expert in Marine Fisheries and concurrently the National Focal Point for Fisheries *Refugia* project in Thailand, gave an interview to the National Broadcasting Services of Thailand-Surat Thani, describing the establishment and operation of fisheries *refugia* at Surat Thani Site. She introduced to the media that fisheries *refugia* project was regionally cooperated by

six countries in Southeast Asian Region objected to establish a regional system of fisheries *refugia* in the South China Sea and Gulf of Thailand. She explained that Koh Sed in Surat Thai Province was one of the two fisheries *refugia* established in Thailand; it played as a safeguard zone for young aquatic animals, particularly blue swimming crabs, in the Gulf of Thailand. She stressed on the technical information supported and the involvement of multistakeholders, particularly local fishers, in establishing fisheries refugia in the area. In her conversation, Operational Management Board for Surat Thani Fisheries Refugia Site at Koh Sed was already established, the members of which were local fishers and related stakeholders in the area. She mentioned that in order to support managing, Department of Fisheries had just conducted the workshop at the community to improve acceptance of ecosystem-based approach to fisheries management. Ms. Praulai finally stated that boundary markers for fisheries *refugia* around Koh Sed would help fishers to notice the refugia area with ease, and the area would be the best practice for sustainable management of blue swimming resources onwards. Press interview took place on Koh Sed at Surat Thani fisheries *refugia* site as shown in Figure 6.
