### HANDOVER OF ACADEMIC DRAFT FISHERIES REFUGIA OF PENAEID SHRIMP IN THE COAST OF WEST KALIMANTAN PROVINCE

#### **Objective of the Meeting**

Academic Draft Fisheries Refugia of Penaeid Shrimp in The Coast of West Kalimantan Province is a scientific study document as material for drafting the government regulations, and it's expected to be one of the solutions to overcome problems related to shrimp fisheries management. The Academic Draft was submitted to the West Kalimantan Provincial Government to be adopted for producing policy and regulation regarding integrated fisheries and habitat management.

#### Time and Venue

The meeting was held on September 14<sup>th</sup> 2022, at the Swiss-Belhotel, Pangkal Pinang City, Wes Kalimantan.

#### **Meeting Notes**

- 1. The meeting began with a report from the Head of the Research Institute for Fish Resource Enhancement (RIFRE) as the National Focal Point, Ir. Iswari Ratna Astuti. She appreciated the team for their hard work in completing the academic draft fisheries refugia document which is part of the output of fisheries refugia activities in Indonesia. Today's meeting was held to submit an Academic Draft Fisheries Refugia of Penaeid Shrimp in The Coast of West Kalimantan Province to the Departement of Maritime Affairs and Fisheries of West Kalimantan Province.
- 2. The meeting was attended by 39 participants, 11 of whom were women. Meeting participants are stakeholders from central government, regional government, village government, fisherman representatives, universities and research institutions (Annex

1).

- 3. The meeting was opened by the Head of the Fisheries Research Center, Yayan Hikmayani, S.Pi., M.Si. She emphasized that fisheries refugia is one of the supports in the existing management and conservation plan. This area is not a prohibited area for fishing, but can still be used sustainably. This academic draft can become content in draft legislation both at the regional and national levels, and can be implemented in West Kalimantan, as well as adapted to other locations that have similar location characteristics.
- 4. Departement of Maritime Affairs and Fisheries of West Kalimantan Province, Herti Herawati, welcomed this meeting. She stated that the results of this activity could also be implemented to support the management of existing conservation areas. Support from other stakeholders is urgently needed due to limited human and financial resources. Departement of Maritime Affairs and Fisheries of West Kalimantan Province, does not provide recommendations for permits for activities that are feared to damage the environment, such as mining activities. She also raised the challenge of low public awareness of the importance of regulating fishing activities. The absence of other livelihood options for fishermen at the closing time and location of fishing is also a problem that must be found a solution together.
- 5. In this meeting, RIFRE presented a video about Fisheries Refugia of Penaeid Shrimp in The Coast of West Kalimantan Province. The video is the summary of Penaeid Shrimp in The Coast of West Kalimantan Province and contains recommendations for management steps which must be carried out next.
- 6. Recommendations in Academic Drafts
  - 1) The potential candidate for the penaeid shrimp refugia area in West Kalimantan with a spatial area of 409,432 ha which includes the sea of Padang Tikar, Delta Pawan, Teluk Batang and Dusun Besar.
  - 2) Make efforts to control shrimp catching through:
    - a. Reduce by 20% the number of currently active lampara and trammel net units;

- b. Rearranging the location of sedentary fishing gear (jermal, sero, and ambai);
- c. Closing the shrimp fishing season (closed season) in November and December.
- 3) Managing shrimp habitat through improving the habitat of penaeid shrimp by rehabilitating mangrove forests, increasing public awareness about environmentally friendly shrimp fishing methods, protecting shrimp habitat, and rearranging sea and river transportation routes in fisheries refugia areas.
- 4) Carry out efforts to develop social, economic, and community institutions which include:
  - a. Improving the quality of data collection for penaeid shrimp fisheries
  - b. Frequent socialization and supervision of the implementation of regulations that have been set.
  - c. Increasing the active role of community institutions d.

Forming Community Monitoring Groups

- e. Preserving local wisdom
- f. Manage a better and scheduled BBM distribution process.
- 5) Regulate permits for the use of sea space including:
  - a. Regulating permits for the utilization of sea space for fishermen (including local communities) with permanent fishing gear, based on Government Regulation Number 21 of 2021 concerning Implementation of Spatial Planning.
  - b. Submit approval for conformity of marine space utilization activities (PKKPRL) according to Minister of Maritime Affairs and Fisheries Regulation Number 28 of 2021.
- 6) Monitoring the management of shrimp fisheries refugia which is carried out every 3 (three) years, accompanied by evaluation every 6 (six) years since it is established.
- 7. Academic Draft of Fisheries Refugia of Penaeid Shrimp in The Coast of West Kalimantan Province was handed over by the Head of the Fisheries Research Center, Ministry of Marine Affairs and Fisheries (MMAF) to the Head Departement of the Maritime Affairs and Fisheries of the Bangka Belitung Province with the Handover Number B.1333/BRSDM.3/RSDM.312/IX/2022.
- 8. On this occasion, the Head of the Fisheries Research Center also gave Map of fisheries refugia area candidates to the Head Department of the Marine and Fisheries of Bangka Belitung Province. The Head of the Fisheries Research Center also gave the copy of Academic draft to the Head Departement of Fisheries North Kayong Regency, Head Departement of Fisheries Kubu Raya Regency, Head Departement of Fisheries Ketapang Regency, Head Departement of Food Security and Fisheries Ketapang Regency, and Head Departement of Regional Planning Agency West Kalimantan Province. The meeting was closed with a photo session.
