Objectives

This program was held to give public awareness program about the Fisheries Refugia Program and to gather feedback from the stakeholders.

METHODOLOGY, ACTIVITIES AND MATERIALS

The Department of Fisheries Pahang invited two (2) speakers to provide inputs for this consultation. They were Mr. Ryon Siow, from the Fisheries Research Institute, Kampung Acheh who gave a talk on the “*Role of Research in the Fisheries Refugia Project*”; and Ms. Norhanida Binti Daud, from the Fisheries Research Institute Batu Maung, who gave a briefing on a “*Socio-economy Study on Lobster Fishermen*”. Each briefing lasted one hour, followed by question and answer sessions to obtain feedback from participants.

A total of 75 participants from the fisheries industry and private and public sectors attended this consultation. The list of participants is given below.

GENDER RATIO:

The participants were made up of 68 men and 7 women.

CONCLUSION:

The briefings by the two speakers enabled the participants to understand the importance of Fisheries Refugias, particularly their aims and objectives. Lobsters, which is a fisheries resource, are threatened by fishing activities such as trawling. The activities of trawlers are known to damage the sea bed, including coral reefs. The spawning season for lobsters occurs between July and October.
