Article 2.-

The commission has following duties:

- Coordinate works, establish, and manage an ecological system and sustainable fisheries resources;
- Monitor and advise a technical working group to prepare principle and plans for management of Marine Fisheries Management Area at Koh Kong province;
- Promote and give advices conservation and development in Marine Fisheries Management Area at Koh Kong;
- Review and approve the proposal for action plans related to Marine Fisheries Management Area at Koh Kong;
- Push, advise, follow up, and monitor the technical working group in the implementation of action plans;
- Promote the extension of the action of marine fisheries management area to involving parties to increase participations and supports;
- Facilitate and solve involved issues in marine fisheries management area at Koh Kong;
- Facilitate and communicate provincial commission of Trat, Thailand to conserve transboundary fishery resources;
- Seek supports from NGOs, development partner, private sectors as well as the establishment of budget management mechanism to ensure sustainably in the implementation of action plans for the marine fisheries management area at Koh Kong; and
- The commission must participate in meeting every 6months at the invitation of the commission head or it is needed, to review and evaluate progressing and issues facing in the process of marine fisheries management area, and to submit a reports of activity results to the Provincial Governor and the Director General of Fisheries Administration.

Article 3.-

The commission has a right to request armed forces from involved authorities for intervention.

Article 4.-

The commission has a right to create and revise the technical working group as assistance, which has composition from Fisheries Administration, Departments, Institutes, Involving authorities, Community Fisheries Representative, and Development Partners Organizations.

Article 5.-

The commission has a right to use the stamp of provincial administration.

Article 6.-

Any decision that has meaning against this decision will be null and void.

Article 7.-

Director of provincial administration, directorate, the unit head under provincial structure, the director of provincial departments, involving institutes/authorities around the province-governor of city or district, and themselves as mentioned in Article 1, must follow that decision effectively starting to sing it from now.

Article 2.-

The commission has following duties:

- Protect and conserve marine fishery resources and refuge in marine fisheries management area at Koh Kong;
- Prepare technical reports and maps to create the management processing of marine fisheries management area at Koh Kong;
- Prepare draft legislative letters to make and manage marine fisheries management area at Koh Kong;
- Prepare management plans for marine fisheries management area at Koh Kong;
- Implement action plans, follow up, and monitor a progressing evaluation of project activities;
- Educate widely extension to people, tourism, and other stakeholders, on management action of marine fisheries management area at Koh Kong;
- Organize a meeting every 6 month or needed to review and discuss every activity, and submit reports to management commission of marine fisheries management area at Koh Kong; and
- Implement other activities delivered by the management commission of marine fisheries management area at Koh Kong.

Article 3.-

The technical working group has a right to request intervention and recommendations from the management commission of marine fisheries management area to do their jobs effectively.

Article 4.-

The technical working group member must participate in a meeting at invitation of the commission head or representative, being agreed by the head of management commission of marine fisheries management area.

Article 5.-

Changing or requesting to enter new member of technical working group must be agreed by the chief of management commission of marine fisheries management area at Koh Kong, though the proposed by the chief of technical working group of marine fisheries management area.

Article 6.-

Director of provincial administration, directorate, the unit head under provincial structure, the director of provincial departments, involving institutes/authorities around the province-governor

of city or district, and themselves as mentioned in Article 1, must follow that decision effectively starting to sing it from now.
