1. Field Trip Objective

- 1) To prepare the action plan for the implementation of mackerel fisheries *refugia* in Koh Kong under the support of SEAFDEC/UNEP/GEF.

2. Involved Person

- 2) There are three leader and officers from Department of Fisheries Conservation, three officers from Fisheries Administration Cantonment in Koh Kong, and other two officers from Koh Kong administration, participating in the action plan for the implementation of mackerel fisheries *refugia* in Koh Kong province (see Annex 1, 2 & 5), naming as following:

- Mr. Ouk Vibol, Director of Department of Fisheries Conservation and National Focal Point
- Leng Sy Vann, Deputy Director of the Department of Fisheries Conservation and NSTFP
- Ms. Va Sotepy, Officer of Department of Fisheries Conservation

3. Field Trip Activities**A. Consultation with Deputy Governor of Koh Kong**

- 3) Teamwork led by Mr. Ouk Vibol met and discussed with Mr. Sok Sothy, Deputy Governor of Koh Kong on the action plan for the implementation of mackerel fisheries *refugia*.
- 4) Mr. Ouk Vibol presented budget workplan from January to March 2019, especially focusing in Koh Kong province. He added that proposed budget in Koh Kong included sub-contract on public awareness raising and volunteer management team, the baseline survey of short mackerel, reviewing the map boundary of mackerel fisheries *refugia*. Those budgets consist of Daily Subsistence Allowance from Fisheries Administration, Koh Kong Fisheries Administration Cantonment, Travelling, boat rental and so on.
- 5) Mr. Sok Sothy supported those works and suggested Mr. Lang Kiri to discuss with Mr. Leng Sy Vann and Ouk Vibol to prepare proposed budget for the extension working and sub-contract between DFC/FiA and Koh Kong FiAC.

B. Discussion with Director of Koh Kong Fisheries Administration Cantonment

- 6) Teamwork met and discussed with Mr. Lang Kiri on the preparation of sub-contract and budget to ensure the process of mackerel fisheries *refugia* management in Koh Kong. The sub-contract was made between DFC/FiA and FiAC in Koh Kong with approval from Deputy Governor of Koh Kong (see annex 4).

C. Visit mackerel fisheries *refugia* site in Peam Krasob

- 7) Teamwork visited the fisheries *refugia* sites at Peam Krasob in order to want and know the situation of the *refugia* site. So far, there is the small number of fishing vessel operating their fishing in small scale, targeting to catch shrimp, crab, and fish.

D. Visit village 4 market and Dornng Tung market

- 8) Teamwork visited Dornng Tung market to see and want to know about the situation of mackerel at each market, if mackerel is abundant or not and big or small size. Generally, in the month of January, the fish is abundant and big, and its price is cheaper around US dollar 2/Kg.

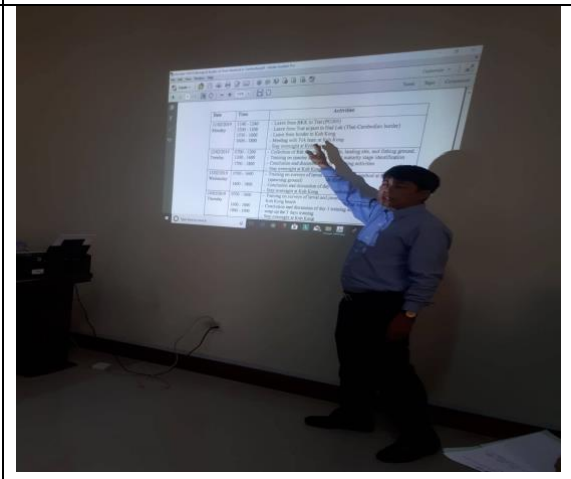

Contract for Assisting in coordination of monthly training, awareness and pilot management activities in Koh Kong

THIS CONTRACT is entered into the force, by and between the Project Team (PT) having its principal place of business at the **Fisheries Administration (FiA)**, the Ministry of Agriculture, Forestry and Fisheries; # 186 Preah Norodom Blvd., P.O. Box 582, Phnom Penh and Koh Kong **Fisheries Administration Cantonment (FiAC)** located at Khemarak Phumin Town, Koh Kong Province (herein called the FiAC-KK).

WHEREAS, the PT wishes to have FiAC-KK performing the work hereinafter referred to, and

WHEREAS, the FiAC-KK is willing to perform this work,

NOW THEREFORE THE PARTIES hereby agree as follows:

1. Responsibility

The FiAC-KK identifies Mr. Lang Kiri, Head of Koh Kong Fisheries Administration Cantonment to perform the Responsibilities specified in the, "Term of Reference and Scope of Work" (Annex A) which is made an integral part of this Contract ("the Work").

2. Terms

The FiAC-KK shall perform work during the period commencing this 1st March to 30th April 2019 or any other periods as may be subsequently agreed by the parties in preparing in the total amount of 800 USD only (eight hundred USD only).

3. Payment

For work rendered pursuant to Annex A, the PT shall pay the FiAC-KK base on 2 phases depend on the completion of the task:

1. Stage 1: when the contract is signed, then the 70% of the total contracted budget (US\$ 560) is paid to FiAC-KK
2. Stage 2: when it is confirmed by PT, that the task has been completed by 100%, then the remaining 30% of the total contracted budget (US\$240) is paid

The amount has been established based on understanding that it includes all of the FiAC's costs as well as any tax obligation that may be imposed on the FiAC-KK.

4. Project Administration

The PT designates **Mr. Leng Syvann**, the Cambodian National Scientific Focal Point for the Project of Establishing and Operating a Regional System of Fisheries Refugia in the South China Sea and Gulf of Thailand, be responsible for payment and monitoring of work done by the FiAC-KK .

5. Performance Standard

The FiAC-KK will work or find the people to undertake the performance work with the standard of professional and ethical competence and integrity.

6. Assignment

The FiAC-KK shall not assign this contract or subcontract or any portion of it without the PT's prior written consent.

7. Law Governing Contract and Language

The contract shall be governed by the laws of the Kingdom of Cambodia, and the language of the contract shall be in English (and Khmer if need).

8. Dispute Resolution

Any dispute arising out of this contract be amicably settled between the parties, shall be referred to adjudication/arbitration in accordance with the laws of the Kingdom of Cambodia.

TERMS OF REFERENCE

TERMS OF REFERENCE FOR INSTITUTION'S ASSIGNMENT ON

Contract for Assisting in coordination of monthly training and awareness activities including pilot management activities in Koh Kong

1. Background

The Southeast Asian Fisheries Development Center (SEAFDEC) has been designated as the Executing Agency of the United Nations Environment Programme (UNEP) implemented, and Global Environment Facility (GEF) financed project entitled, "*Establishment and Operation of a Regional System of Fisheries Refugia in the South China Sea and the Gulf of Thailand*" (referred to hereafter as the SEAFDEC/UNEP/GEF Fisheries *Refugia* Project). This project has the following objective: "***To operate and expand the network of fisheries refugia in the South China Sea and Gulf of Thailand for the improved management of fisheries and critical marine habitats linkages in order to achieve the medium and longer-term goals of the fisheries component of the Strategic Action Programme for the South China Sea.***"

SEAFDEC and the Fisheries Administration, for the execution of the SEAFDEC/UNEP/GEF Fisheries *Refugia* Project in Cambodia have, on the basis of their respective mandates, a common aim in the furtherance of integrated fisheries and habitat management to achieve the targets of the fisheries component of the Strategic Action Programme for the South China Sea. Additionally, the parties to this instrument are committed to the implementation of the ASEAN-SEAFDEC Regional Guidelines for Responsible Fisheries in Southeast Asia and the 2011 Resolution on Sustainable Fisheries for Food Security for the ASEAN Region Towards 2020, in which the Ministers responsible for fisheries resolved *inter alia* to "*Implement effective management of fisheries through an ecosystem approach to fisheries that integrates habitat and fishery resource management aimed at increasing the social and economic benefits to all stakeholders*".

2. Objective to the FiAC-KK

The FiAC-KK is willing to assist the PT to coordinate monthly training and awareness activities including pilot management activities in Koh Kong. Its work is started from 1st March to 30th April 2019.

3. Description of the Required Services

The specific tasks of the institution as follows:

1. *Prepare the budget for public awareness raisings and submit to PT for reviewing and approval;*
2. *Organize a serial public awareness raisings related to fisheries Refugia site for short mackerel and mackerel spawning season;*
3. *Form a patrol team with multi stakeholder and prepare patrol plan;*
4. *Prepare the activities report with approved document; and*
5. *Coordinate to stamp the map of mackerel fisheries refugia in Peam Krasob, Koh Kong province.*

4. Duration and Timing

It is proposed that the FiAC-KK will work for the project from 1st March to 30th April 2019.

5. Monitoring/Evaluation

The Director of the Department of Fisheries Conservation and the Deputy Governor of Koh Kong Province are jointly responsible for monitoring and evaluation of the performance of the FiAC-KK.

6. Qualification of the Consultant

The FiAC-KK shall select the people who have professional working experience and advance university education in the fields indicated in this ToR. Good coordination and planning skills are necessary.
