## 1. CHAIRPERSON KEYNOTE

1.1 Mr. Hadil bin Rajali informed to the committee that he has been appointed as the National Focal Point for Scientific and Technical Committee whereas Mr. Richard Rumpet as an Alternate National Focal Point for Scientific and Technical Committee.

## 2. DISCUSSION

### 2.1 Refugia Project in Kuala Baram, Sarawak

- 2.1.1 The status of the project was presented by Madam Nurridan binti Abdul Han.
- 2.1.2 The objective of this study was to identify the nursery areas and to assess the source of tiger shrimp juveniles in Kuala Baram, Sarawak.
- 2.1.3 Tiger prawn study was conducted in March and April 2019 which focused on the juvenile stage.
- 2.1.4 The latest update of the study is to identify and prepare mapping in three (3) study areas in Miri namely Lutong river, Pasu River and Sibuti River.
- 2.1.5 The Sarawak Forestry Department has informed that the Kuala Baram area has been gazette as a Totally Protecting Area where development is not possible.

## 2.2 Refugia Project in Tanjung Leman, Johor

- 2.2.1 The status of the project was presented Mr. Ryon Siow
- 2.2.2 There are three (3) species of lobsters caught in the South Pahang and East Johor areas namely *Panulirus ornatus, Panulirus polyphagus* and *Thenus orientalis*.
- 2.2.3 There are several activities that have been carried out throughout the study:
  - a. Lobster landing data
  - b. Lobster stock assessment
  - c. Lobster larvae study (filosoma),
  - d. socioeconomic study
  - e. Stakeholders' consultations
  - f. Fisheries Refugia Information Centre

#### 2.3 Budget

- 2.3.1 The allocation for the first year (2018) was USD27, 230 while the allocation for the second year (2019) was USD15, 131.66.
- 2.3.2 In 2019, FRIKA has received an allocation of RM150, 000.00 and RM20, 000.00 for the socio-economic from the national fund. Whereas, FRI Bintawa has received RM 100, 000.00 for the project implementation.

## 2.4 Costed Quarterly Work Plan

2.4.1 All participating universities are requested to submit their proposal to the secretariat by May 3, 2019.

2.4.2 The committee has been informed that drafts of Costed Quarterly Work Plan of Q2 and Q3 have been prepared.
