1. Open meeting

- 1.1 Consultation meeting on reviewing and verifying a final draft of 5 year management plan for MFMA at Koh Po and Koh Tonsay Archipelago, Kep was organized by Fisheries Administration (FiA) of Cambodia collaborating with Kep Provincial Hall Administration and Kep Fisheries Administration Cantonment on 13 January 2020, funded by SEAFDEC/UNEP/GEF Fisheries Refugia. The meeting was conducted at Kep Provincial Hall Administration and was attended by 5 participants in total from Kep Provincial Hall Administration, Fisheries Administration, and Department of Agriculture, Forestry, and Fisheries (see Annex 1, 2 &3).
- **1.2 Mr. Prom Kunti**, Deputy Governor of Kep welcomed and expressed thank very much to Director of Department of Fisheries Conservation and their colleagues, and Deputy Director of Agriculture, Forestry, and Fisheries, providing us chances to meet and discuss furthermore on final draft of 5 year management plan in order to ensure that the management plan is more and more better, and implemented more effectively. That is the last meeting to discuss that document, which will plan to be submitted to Kep Governor for approval and signature on 3rd February 2020.

2. Presentation of Final Draft of 5 year Management Plan for MFMA in Kep province

2.1 Mr. Ouk Vibol expressed that the document of 5 year-management plan for MFMA, Kep province reached final draft, so he would like to request all participants, especially Deputy Governor of Kep help to check its meanings and spellings. The management plan is 6 Objectives with the cost of US dollar 744,420 including 1st and 2nd objectives are the main objectives, focusing on strengthening law and regulation enforcement to crack down illegal fishing and other offenses effectively with total amount of US dollar 233,220 and improving a critical habitat restorations and protections to ensure fisheries resource stock in the nature with total amount of US dollar of 230,100. However so far there are some budgets in hand for the implementation of working activities such as US dollar 100,000 from FiA; US dollar 100,000 from MCC; US dollar 70,000 from Fisheries *Refugia* Project SEAFDEC/UNEP/GEF; US dollar 30,000 from FiAC in Kep; US dollar 40,000 from EU; and other budget from FAO and FACT.

3. Discussion on Final Draft of 5 Year Management Plan for MFMA in Kep

- **3.1 Mr. Prom Kunti** raised that generally, the management plan is well done, but it still mistakes spelling, so please meeting to check each paragraph and correct one by one paragraph.
- **3.2 Mr. Pa Kim Ang, Deputy** Director of Department of Agriculture, Forestry, and Fisheries informed the meeting that he supported the 5 year management plan, which is a good plan and agreed Deputy Governor's proposal to check spelling. He thought that when the plan will be approved by Kep Governor, it becomes an advantaged document to seek out budget from donors and development partners for the implementation of activities.
- **3.3 Mr. Ouk Vibol** supported and agreed that proposal to correct it by each paragraph.
- 4. Discussion on Preparation for Schedule for the Meeting of Provincial Management Committee
- **4.1 Mr. Prom Kunti** informed that preparation of the schedule for the meeting of provincial management committee is to know who join that meeting and what they got responsibility for. It is easy for them to prepare document and letter to be submitted to Kep Governor for the permission of the meeting organization. He added that the schedule for the meeting should be from FiA, FiAC, and MCC to join that meeting, which they can present their progress report done in the past.

- **4.2 Mr. Ouk Vibol** expressed that Deputy Governor of Kep and as Chair of TWG should also present progress report done since Sept 2018 until now. For progress report, FiAC and he will help to prepare slide for the presentation. Regarding participants, they will be invited to join the meeting coming from the Provincial Management Committee and Technical Working Group together. In that case, Kep Provincial Hall Administration will prepare invitation letter to all members from the Management Committee and Technical Working Group. Moreover, he will wish to present a final draft of 5 year management plan for MFMA in Kep province and he requested **Mr. Leng Sy Vann**, Deputy Director of Department of Fisheries Conservation to make a presentation on the MAFF's proclamation on establishment of Marine Fisheries Management Area at Koh Po and Koh Tonsay Archipelago, Kep.
- **4.3 Mr. Pa Kim Ang** agreed those proposals and informed that the schedule for the Meeting of the Provincial Management Committee should discuss detail on table with setting time and describing activities for whom get responsible.
- **4.4 Mr. Pro Kunti** proposed the meeting starting to discuss on the table of the schedule for the Meeting of Provincial Management Committee and the result of the schedule for the meeting appeared as in Annex 4.

5. Close meeting

5.1 Mr. Prom Kunti thanked very much to Director of Department of Fisheries Conservation and Deputy Director of Department of Agriculture, Forestry, and Fisheries, preparing a meeting to discuss a final draft of 5 year management plan for MFMA in Kep province and organization of schedule for the meeting of Provincial Management Committee under presided by Kep Governor. The meeting is closed at 4:00pm with fruitful results of the meeting.
