1. Opening a meeting

- 1.1 The stakeholder consultation meeting at provincial level to verify the map of marine fisheries management area including fisheries refugia in Kampot with Development Companies was organized by Fisheries Administration(FiA) of Cambodia collaborating with Kampot Provincial Hall Administration and Kampot Fisheries Administration Cantonment on 23 September 2021, funded by SEAFDEC/UNEP/GEF Fisheries Refugia, under presided by Mr. Pel Kosal, Deputy Governor of Kampot province and is also the chairperson the meeting
- 1.2 The meeting was conducted at Kampot Provincial Hall Administration, which was attended by 21 participants in total from Fisheries Administration, Fisheries Administration Cantonment in Kampot, Provincial Department of Environment, Provincial Department of Agriculture, Forestry, and Fisheries, Department of Land, Urban, Construction, and Cadastral, Department of Public Works and Transports, Provincial Police, Maritime Police 241, Bokor City, and NGO (see Annex 1&3).
- 1.3 Mr. Pel Kosal expressed thanks to Mr. Ing Try, Deputy Director General of Fisheries Administration and his colleagues, and other participants from provincial departments involved, taking their opportunity to join that meeting today. This meeting today was to reply to the meeting spirit on 8 September under presided by Kampot provincial governor, and agreed to continuously discuss and verify the map of marine fisheries management area at Prek Thnaot and Koh Touch commune, Bokor city, Kampot province with development companies in the management area. He declared to open the meeting and after that he proposed Mr. Ing Try to give a speech to the meeting.
- 1.4 Mr. Ing Try informed the meeting that this was responsible job altogether and he proposed the Department of Land, Construction Urbanization, and Cadastral to review the map altogether. He added that Fisheries Administration set indicators of the establishment of marine fisheries management area, at least one place in coastal provinces to comply with strategic plan of the Royal Government of Cambodia. Thus he proposed the meeting to review the map before submitted to provincial governor for approval and signature.
- 1.5 Mr. Pel Kosal proposed Department of Land, Construction Urbanization, and Cadastral to present the Development Companies in the marine fisheries management area to the meeting.

2. Presentation on Development Companies in the Marine Fisheries Management Area

- 2.1 Mr. Seng Piseth informed the meeting that three development companies have a plan to invest in the marine fisheries management area such as Ching Kor, Tycoon Try Pheap Companies, and TP Moral Ltd. Ching Kor and Tycoon Try Pheap companies have addressed already, but a new company (TP Moral Ltd.) does not solve yet because the company just received the permission for the investment from the Minister Cabinet of Cambodia No. 1114 Sor Chor Nor dated 31 December 2020. He added that the boundary of the map of marine fisheries management area has also impacts on the Vin Hour Investment Company at Koh Touch commune, Bokor city, Kampot province.
- 2.2 Chairperson of the meeting proposed the meeting to consider and discuss these issues

3. Discussion on Development Projects in the Marine Fisheries Management Area

- 3.1 Chairperson of the meeting opened a floor for discussion
- 3.2 Miss. Leng Phalla informed the meeting that Ching Kor Company has the size of 640ha based on its investment proposal and Tycoon Try Pheap Company has the size of 657ha.

- 3.3 Mr. Ing Try replied that Vin Hour Company has the size of 70ha in length and 30ha in width and the investment documents of this company is available in the Department of Land, Construction Urbanization, and Cadastral. As for Tycoon Try Pheap Company, the investment documents of the company have not been submitted to CDC (Cambodian Development Council) yet. Ching Kor Company is also available of the investment documents in the Department of Land, Construction Urbanization, and Cadastral. Thus, Fisheries Administration proposed the Department of Land, Construction Urbanization, and Cadastral to review those documents.
- 3.4 Chairperson of the meeting said that it is now available of third development company coming to invest in this management area, naming TP Moral Ltd in the size of 888ha
- 3.5 Mr. Ing Try replied that development companies in water area is needed to do EIA (Environmental Impact Assessment) on natural resources, so CDC should consider the investment projects in land area.
- 3.6 Mr. Kong Bunra informed the meeting that Tycoon Try Pheap Company submitted proposal for the investment in the size of 600ha to the Royal Government of Cambodia and the Master Plan for the investment has also been done.
- 3.7 Mr. Ing Try replied that if the company is available of UTM coordination and has proposed the size of the investment to Minister Cabinet, so the Minister Cabinet accepts the proposed size only.
- 3.8 Mr. Sar Sorin informed the meeting that this map was done based one Tycoon Pheap Company requirement and sites affecting were cut off already, so please keep in the size of 600ha.
- 3.9 Chairperson of the meeting supported and accepted the size proposed to CDC only.
- 3.10 Mr. Ing try replied that when discussion meeting will be conducted with CDC, cutout or land refill cannot be made, exception for the investment of special economic zone.
- 3.11 Mr. Chan Rith informed the meeting that it should not be available of TP Moral Ltd to invest in the management area because there are the plenty of coral reef in those sites, where are attractive sites for serving tourism sector.
- 3.12 Mr. Ing Try replied that Sor Chor Nor letter from the Minister Cabinet can be deleted as long as the investment affecting biodiversity and natural resources seriously.
- 3.13 Miss. Leng Phalla informed the meeting that Teamwork from Fisheries Administration will cut off land area affecting Vin Hour Investment Company.
- 3.14 After discussion, Chairperson of the meeting summarized following meeting results:
 - Supported the Department of Land, Construction Urbanization, and Cadastral to produce two kinds of Map, 1st Map cuts off water area from impact of the development project of TP Moral Ltd, and 2nd Map keep whole map without TP Moral Ltd, but keeping Ching Kor and Tycoon Try Pheap Companies,
 - 2) Agreed to continue discussion meeting with Kampot Provincial Governor to approve those maps, and
 - 3) Supported to accelerate this job completely before the month of November to reply to Fisheries Administration Indicators.

4. Close meeting

4.1. Mr. Pel Kosal expressed thank very much for all participants, especially Mr. Ing Try, Deputy Director General of Fisheries Administration, taking their opportunities to join this meeting, and making this meeting today to get fruitful and successful. He declared to close the meeting at 5:00pm at the same day
